Our access routes are designed for wheel chair access  
Acoustics in the hall are not good because of the height of the ceilings.  
Classrooms are all on one level but are small.

The school is required to produce a disability equality and access plan for increasing disabled pupils' participation in the school curriculum etc. This was achieved and is incorporated in this plan.

## **Accessibility improvements since September 2014**

Signage improved.

Lighter paintwork in classrooms as part of rolling redecoration programme.

Toilets have been refurbished with non-slip flooring.

School kitchen has been resurfaced with new non-slip flooring.

The classrooms are carpeted throughout to suppress noise levels, provide safe surfaces for children and staff and visually enhance the environment.

Atrium and hall roof windows have all been replaced for improved ventilation, protection from excessive heat or leakage from rain.

Blackout blinds have been fitted as protection from glare.

All school pathways and playground sections resurfaced

Disability handles in Reception class toilets to enable toileting for disabled pupils in class.

Two disability-friendly toilets in use for pupils in Y1-6, staff and visitors.
